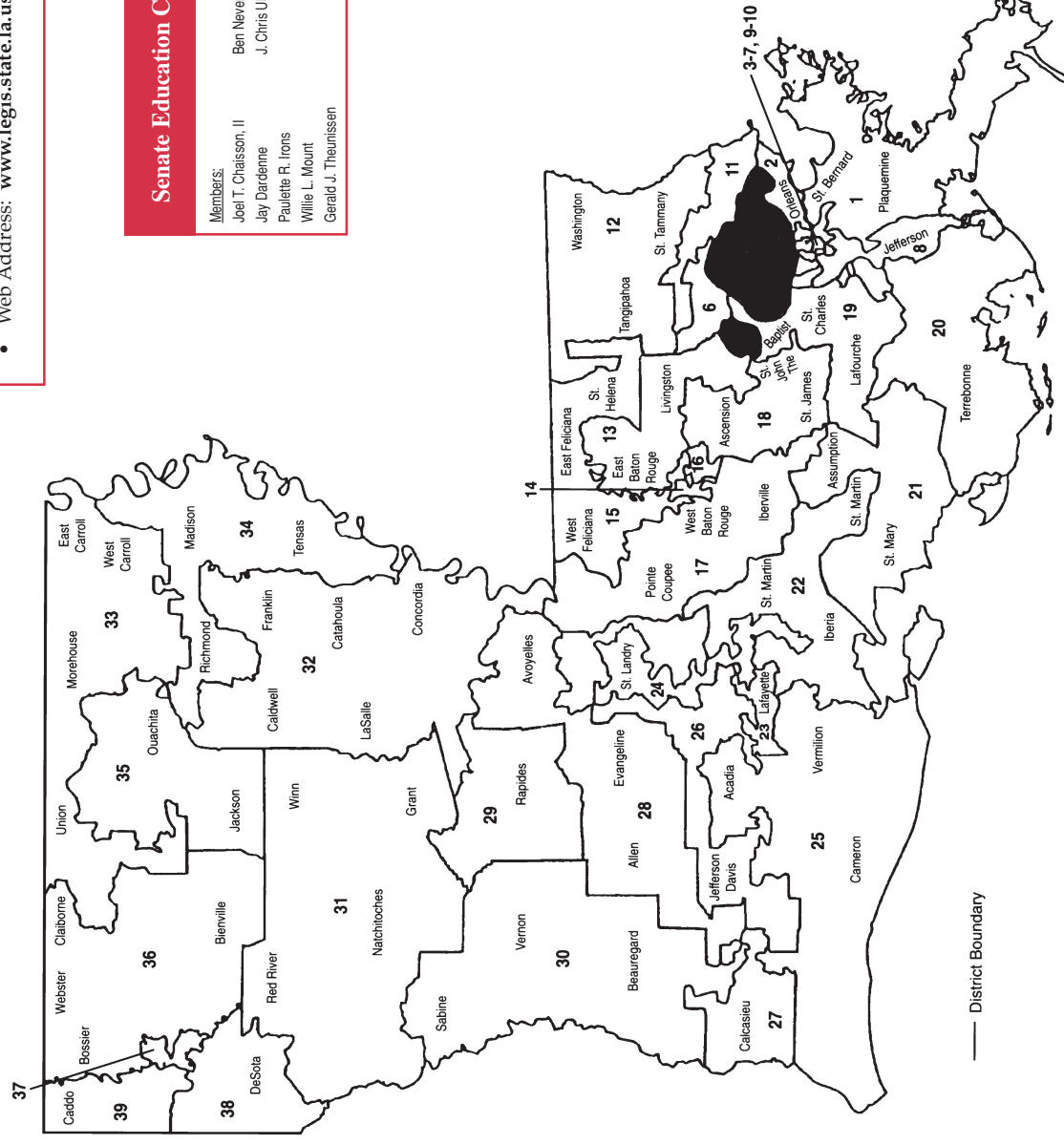

### Helpful Hints

- To have messages delivered to legislators through the House or Senate switchboard/message center, the House number is (225) 342-6945, and the Senate number is (225) 342-2040.
- The salutation is "Dear Senator Deaux" or for representative, "Dear Representative Deaux." If possible, type your letter. A personal note on your stationery is more effective than a form letter.
- Be specific: Write only about a single bill or issue in your letter and refer to that bill or issue by its number or common name. When you are writing or speaking about UL Lafayette be sure to mention the University by name. Be brief... include your full name, return address and phone number.
- A letter written to a legislator to congratulate him on a job well done is both appreciated by the legislator and will serve UL Lafayette's cause well.

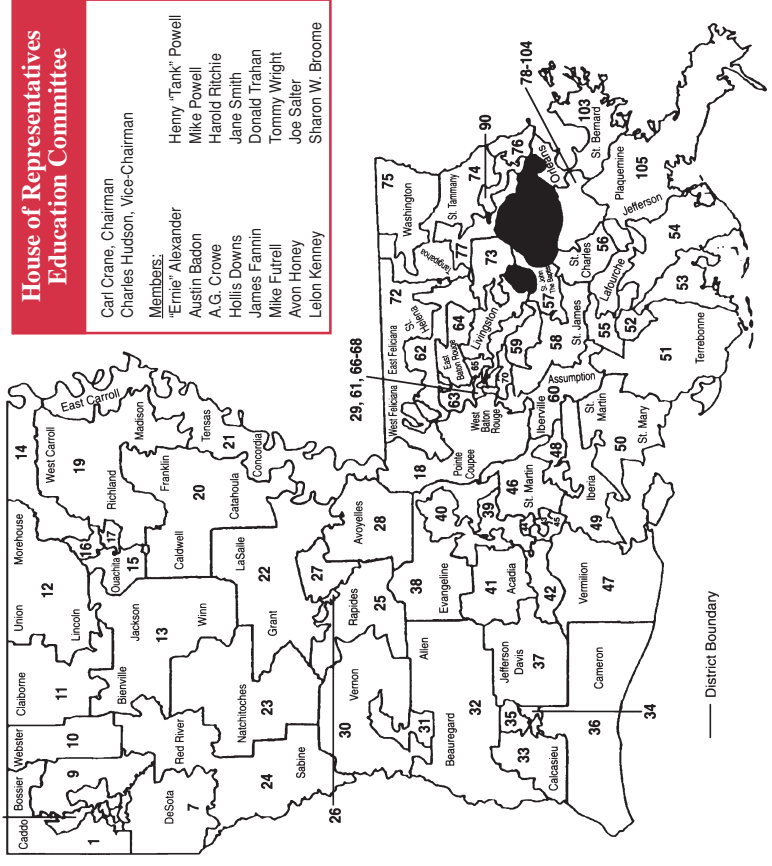
